Motion made by Sheehan and seconded by Taylor to approve the Level Two Benefits Review request from Joseph Kukla with respect to only those HRA claims incurred while he was a participant in the VEBA's HRA Plan (4/1/2016 – 5/31/2016) and allow the submission of additional claims through the end of the HRA Plan's grace period (3/31/2016). Motion carried.

Ethics Policy Mr. Castle presented the draft Board Ethics Policy. He requested that Trustees review, make recommendations and discuss at March 14, 2016 meeting.

Unfinished Business

Trustee Compensation – Taylor submitted a letter indicating that he would not accept compensation. Motion made by Clark and seconded by Allen for counsel to draft an amendment to the Trust Agreement that will allow members to abstain from taking the monthly stipend. Motion carried.
