## **Unfinished Business**

### **A. Priority Health Renewal 2023**

LaDominic Brandon Berkley updated Chairman Opolski that Priority Health will be unable to provide the Part B Buydown for the 2023 benefit year. They will work on putting it in place for 2024. The Admin Committee discussed options in detail.

**Motion** – To recommend to the Board to approve and accept the benefit enhancements offered by Priority Health for the 2023 Plan Year as follows: PPO - Podiatry Copays reduced to \$15/visit, MOOP reduction to \$750, DME from 10% to 0%, and for HMO - MOOP reduction to \$1,500, Podiatry Copay reduced to \$15/visit, Diagnostic Tests reduced to \$10 copay. In addition increase HRA Disbursement by \$10/per month with exception of the HRA for Non-Medicare Eligible Duty Disabled which is capped at \$400 per month.

### **B. Dental & Vision Coverage 2023**

Ms. Shippy provided the Admin Committee with information regarding the Delta Dental and VSP renewal and possible benefit enhancement. The Board is considering making some changes and discuss took place regarding options.
