Graystone Consulting – Burton Carlson (via phone)

Mr. Carlson updated the Board regarding the market value of the B Notes and recent trade activity noting that the current Bond valuation is remaining steady and non-eventful. Per J.J Kenny Drake, the current Bond price is \$87.15. The price is down \$0.70 since last month of \$87.85.

Mr. Carlson provided the Board with a cash flow analysis through the 2020 calendar year which is similar to last month, there are slight changes as the January 2019 financials were used. He noted that the cash balance increased in January from December, which is not the norm. He also noted that the most recent sale of the bonds is not reflected in this analysis.

BeneSys confirmed that the February and March 2019 financials are complete and will send those to Mr. Carlson.

Further discussions regarding a Fundamental Advisor that is focused on Municipality Bonds. Mr. Carlson advised that they are not on the Greystone platform but would look further into it.

Jim Pranschke from GRS joined the meeting via phone to review the RFP, the RFP is almost the same as the one that was sent out in 2017 and he plans on finalizing and sending around June 27th or 28th. He will also work on adding buyup options into the RFP's he will send. He plans on coming to the August 28th meeting to discuss the results of the RFP.

a. Weiler Settlement Surplus Funds

Mr. Castle spoke with attorney Leggio about the surplus funds. Mr. Leggio advised Mr. Castle that he intends to file the necessary motions within the next month requesting Court approval for release of the funds to the VEBA.

Mr. Castle advised he is working on additional items with ABS to complete the transition to BeneSys. He has been in contact with ABS to finalize data issues as well as audit and actuary requests.

Correspondence

Chairman Opolski received correspondence from the host of the www.dethctveba.org website, Web Ascender. The email included information on cost of keeping the site active although Bassett and Bassett is no longer working with the VEBA. Mr. Castle was instructed to send a letter to terminate.

Ms. Gjorgjevski discussed an issue that occurred in June with the reoccurring HRA checks. The issue was quickly escalated and resolved and only 1 known member was impacted by the issue. BeneSys has since implemented additional steps to assure that the issue is not repeated.

GRS provided a correspondence with some staffing changes and who our contacts will be with these changes.

Mr. Opolski provided the Board an update on communication between himself and BeneSys, he advised that he is working with BeneSys to complete questions and concerns in a timely manner, he has nothing more to report on at this time.
