### Priority Health – LaDom Brandon Berkley & Rob Roberts

Ms. Berkley discussed with the Board after contact from Chairman Opolski they have discovered that there has been a delay in the \$50 Buy Back for some members. No reasoning as to which members this is happening to or why. Unknown when CMS will have this issue corrected. Ms. Berkley will continue to keep the Board up to date on findings. Discussion took place regarding this issue and possibly options for members.

Chairman Opolski mentioned that Priority Health Customer Service Reps are telling members who are having issues with the \$50 Buy Back to call him which is inappropriate. Ms. Berkley will investigate this and provide training to the Customer Service Reps.

### **E. VEBA Grant Funds**

Mr. Judd provided, at the Board's request, the letter to Susan Corbin, the Director of the Michigan Department of Labor and Economic Opportunity regarding the Detroit VEBA Healthcare Grant fund. Extensive discussion took place.

Chairman Opolski provided the Board with a letter from Butzel Long, Attorneys =for the Retired Detroit Police and Firefighters Association regarding research, guidance, and potential representation in a litigation matter against the State of Michigan and its affiliates. Discussion took place regarding this matter and whether the VEBA wanted to be a party if the RDPFFA moves forward with litigation.

### **F. Priority Health Census Date Request**

Ms. Berkley had requested that BeneSys provide Census information to Priority Health of members who are not enrolled in Priority Health and those who will be turning 65 in 2024. She explained that she would like to be able engage these members by providing a variety of education touchpoints. The Board discussed this in detail and will have Mr. Castle respond to Priority Health regarding this request.

### **B. COPS Trust/Delta Dental Dual Enrollment**

Ms. Crosby explained to the Board that she was performing an invoice audit and came across two members who are both retirees and married to each other. They each have the other covered for Dental coverage, known as dual enrollment. She reached out to Karen and Tom at COPS Trust to see if Delta Dental had approved for members to dual enroll. Delta Dental does allow this as part of the contract that COPS Trust has with them. The Board discussed the Coordination of Benefits around this. Chairman Opolski asked for a list of members who have a dual enrollment to see how many are paying two premiums for their families.

## **Unfinished Business**

### **A. Change Healthcare Cyber Attack – Vendor Responses**

Ms. Crosby reached out to Priority Health, Delta Dental and VSP to get their responses to the Change Healthcare Cyber Attack and how it may affect the members of the VEBA. Those responses were all provided to the Board for review.

### **B. BeneSys – HRA Overpayment**

Ms. Crosby updated the Board that they have received reimbursement from the five members who were paid claims in error during January 2024. This matter is resolved.

### **C. VEBA Grant Fund Correspondence**

Correspondence from Director of Legislative Affairs for the Michigan Department of Labor and Economic Opportunity, Jayshona Hicks, and Matt Sowash, Michigan Legislative Consultant regarding the VEBA Grand Fund \$10M being awarded to the Coalition of Detroit Public Safety Unions Trust were provided for the Board's review.
