Legal Report

General Counsel requested limited online access to the RHC Trust's accounts at Fifth Third Bank for purposes of reconciling apparent accounting discrepancies in the Trust's HRA claims account.

The Board was supplied with a draft of the RFP for audit services. Board members along with members of ABS will review the draft and discuss any changes at the November 23rd, meeting.

General Counsel discussed that preparation has begun on the Trust's Plan Document to be finalized by the end of the year and be ready for applying for an IRS Determination Letter.

Old Business

Legal Counsel supplied the Board with an update on discussions held with the RDPFFA's Special Counsel. Mr. VanOverbeke stated that he discussed the issue of "Trustee Compensation" with Special Counsel for the RDPFFA and is waiting for a response.

New Business

HRA claims reimbursements have been processed through November 3, 2015. As of November 3, 2015 the RHC has paid out \$1,335,614,57 in HRA claims.

ABS updated the Board on the ongoing "Open Enrollment" process, and supplied the Board with examples of "Dependent Eligibility Language". ABS stated that there have been approximately 786 enrollment changes as of November 7, 2015.
