NOTICE TO PARTICIPANTS

Please be advised that, effective November 1, 2022, the Local 639 Legal Services Trust Fund ("Fund") has revised its roster of Participating Attorneys who have contracted with the Fund to provide legal service benefits to eligible participants under the terms of the Local 639 Legal Services Plan ("Plan"). This new roster of Participating Attorneys, which is attached to this Notice, supersedes the prior roster dated March 2018.

Participating Attorneys are attorneys who have agreed to participate in the Legal Services Plan at an hourly rate approved by the Board of Trustees, which is currently \$125 per hour. All of the attorneys on the Roster are available for consultation. The areas of concentration for each attorney or law firm are included in the Roster.

If you are currently receiving legal services for benefits covered by the Fund from a Participating Attorney who was on the March 2018 roster, but who is not on the attached updated Roster, the Fund will continue to cover your benefits for that particular matter, subject to the terms of and up to the applicable maximums provided by the Plan.

This is a reminder that, under the terms of the Plan, you are not required to consult with or be represented by a Participating Attorney. You may contact any attorney of your choosing. If you engage a non-Participating Attorney, however, you must make your own fee agreements. Claims for the services of non-participating attorneys can be paid by the Plan, but they are subject to the same maximum hourly rate of \$125, the Plan's hours limitations, and other regulations that are specified in the Plan's Summary Plan Description ("SPD").

To use one of the Participating Attorneys identified in the Roster, call the Participating Attorney directly. Identify yourself as a participant in the Local 639 Legal Services Plan. The Attorney will contact the Fund Office to verify your eligibility for benefits.

The Attorney will bill the Plan directly for professional services up to the limits described in the SPD. You will be billed only for costs, such as court filing fees and any professional fees that exceed the benefit maximums in the Plan.
