**Summary Annual Report for
LOCAL 966 HEALTH FUND**

This is a summary of the annual report for LOCAL 966 HEALTH FUND, EIN 13-1911036, Plan Number 501, for the period January 1, 2020 to December 31, 2020. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has a contract with THE UNION LABOR LIFE INSURANCE COMPANY to provide Stop Loss Insurance. The total premiums paid for the plan year ending December 31, 2020 were \$161,433.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$310,761 as of December 31, 2020, compared to \$1,603,802 as of January 1, 2020. During the plan year the plan experienced a change in its net assets of \$-1,293,041. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$4,188,956 which included employer contributions of \$4,160,121, employee contributions of \$9,304, other contributions of \$0, gain/loss of \$0 from the sale of assets, and earnings from investments of \$19,531.

Total plan expenses were \$5,481,997. These expenses included \$372,850 in administrative expenses and \$5,109,147 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
