**Summary Annual Report for**  
**LOCAL 966 HEALTH FUND**

This is a summary of the annual report for LOCAL 966 HEALTH FUND, EIN 13-1911036, Plan Number 501, for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The plan has a contract with THE UNION LABOR LIFE INSURANCE COMPANY to provide Stop Loss Insurance. The total premiums paid for the plan year ending December 31, 2022 were \$253,530.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was (\$703,006) as of December 31, 2022, compared to \$389,528 as of January 1, 2022. During the plan year the plan experienced a decrease in its net assets of (\$1,092,534). This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$4,550,526 which included employer contributions of \$4,192,433, employee contributions of \$28,442, other income of \$346,752, and losses from investments of (\$17,101).

Total plan expenses were \$5,643,060. These expenses included \$370,934 in administrative expenses and \$5,272,126 in benefits paid to participants and beneficiaries.
